Rules and Regulations for Food Vendor Space

Food Vendors:

Food vending is located opposite the covered arena. Because size requirements may affect placement, all spaces will be assigned at the discretion of the MIACS. Utilities are not provided. However, standard 110 Volt electrical service requiring up to 10 amps is available at an additional \$100 per hook-up.

General Conditions:

All commercial vendors must prominently display the prices of each item including tax. All spaces must remain intact until 5:00 PM on the last day of the MIACS. All concessionaires are required to use code approved lights, wire and extension cords in their respective exhibit area. MIACS retains the right of final inspection of all service connections, in accordance with Miami-Dade County Code.

Set-Up:

There is absolutely no admission to the Ronald Reagan Equestrian Center prior to Friday March 19, 2010 prior to the start of the MIACS on Saturday, March 20, 2010, unless arrangements have been made with MIACS Management. All exhibits must be in place NO LATER THAN 10:00 A.M. ON March 20, 2010.

Insurance:

All exhibitor/vendors must provide a Certificate of General Liability Insurance in the amount of \$1,000,000 naming Miami-Dade County and South Florida Autism Charter Schools, Inc. as additionally insured. Exhibitor/vendor expressly understands and agrees that any insurance protection required by the Contract or otherwise provided by exhibitor/vendor shall in no way limit the responsibility to indemnify, keep and save harmless and defend the County or its officers, employees, agents and instrumentalities as herein provided.

Health Permits/Sales Tax:

Health Permits are required for ALL vendors selling edible products. The Division of Hotel & Restaurant Inspectors will be on site prior to opening for licensing and collection of applicable fees. Florida sales Tax is to be charged on all retail sales of merchandise and paid to the State of Florida.
